The following Act of the Legislative Assembly, Puducherry received the assent of the Lieutenant-Governor on the 28th day of March 2008 and is hereby published for general information :—

THE APPROPRIATION ACT, 2008

(Act No. 2 of 2008)

(28-3-2008)

AN

ACT

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the Union territory of Puducherry for the services in respect of the period from 1-4-2007 to 31-3-2008

BE it enacted by the Legislative Assembly of Puducherry in the Fifty-ninth Year of the Republic of India as follows :—

Short title

1. This Act may be called the Appropriation Act, 2008.

Supplementary appropriation of Rs. 186,35,11,000 from out of the Consolidated Fund of the Union territory of Puducherry for the period from 1-4-2007 to 31-3-2008.

2. From and out of the Consolidated Fund of the Union territory of Puducherry, there may be paid and applied further sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to the sum of one hundred and eighty-six crores, thirty-five lakh and eleven thousand rupees, towards defraying the several charges which will come in the course of payment during the period from 1-4-2007 to 31-3-2008 in respect of the services specified in column (2) of the Schedule.

Appropriation.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union territory of Puducherry by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.

THE APPROPRIATION (VOTE ON ACCOUNT) ACT, 2008

(Act No. 3 of 2008)

**to authorise payment and appropriation of certain sums
from and out of the Consolidated Fund of the
Union territory of Puducherry for the services
in respect of the months of April, May, June and
July, 2008.**

BE it enacted by the Legislative Assembly of Puducherry in the Fifty-ninth Year of the Republic of India as follows :—

1. This Act may be called the Appropriation (Vote on Account) Act, 2008. Short title

2. From and out of the Consolidated Fund of the Union territory of Puducherry, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to the sum of one thousand one hundred and eleven crore and eight lakh rupees, towards "Vote on Account" for defraying the several charges which will come in the course of payment during the months of April, May, June and July, 2008 in respect of the services specified in column (2) of the Schedule. Vote on Account for Rs. 111,08,00,000 out of the Consolidated Fund of the Union territory of Puducherry for the months of April, May, June and July 2008.

Appropriation. 3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union territory of Puducherry by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
